WHEN AN EVENT REQUIRES HOURS BEYOND THE TIME BLOCK, A FEE WILL BE CHARGED BASED ON THE "ADDITIONAL HOUR" RATE FOR THAT TIME SLOT.				
<b>SECURITY OFFICER:</b> THE PRESENCE OF A UNIFORMED OFFICER DURING EVENT HOURS THROUGH THE END OF THE EVENT IS REQUIRED WHEN ALCOHOL IS SERVED AND/OR MORE THAN 150 GUESTS ARE EXPECTED. THE FEE IS \$35 PER HOUR WITH A MINIMUM REQUIREMENT OF 4 HOURS.				

**INCLUDED:** Included in the main hall rental is use of: the kitchen, patio, and mezzanine areas, 100 folding chairs, and 10 rectangular tables (6" L x 30" W). Additional furnishings are available for a rental fee as listed on the reverse side.

**FOOD SERVICE:** Food service must be provided by a licensed/insured (minimum aggregate liability of \$1,000,000) caterer. Catering is open to any food service organization meeting this requirement.

**REFUND POLICY:** Your rental deposit is non-refundable. However, if your event is cancelled and the date is re-booked, your deposit will then be refunded less a \$75 service charge.

**TO RESERVE:** A deposit of one half of the base rental fee is required with a signed Rental and Deposit Agreement. The final contract will be sent out 2 months prior to the event. Full payment plus the refundable security deposit **must** be submitted with the final contract to The Barn **3 weeks** prior to the event.
